IADMS Recognized Professional Competency Portfolio Guidelines

IADMS Recognized Professional (IRP) Competency Guidelines

This document outlines the competencies required to achieve the status of an IADMS Recognized Professional (IRP). These competencies represent the minimum standards necessary to ensure safe, lawful, and effective professional practice. Individuals recognized by IADMS are expected to uphold these standards consistently within their country of practice.

There are multiple valid ways to demonstrate each competency, and the way you meet these standards may evolve over time in response to advancements in technology or changes in your professional approach. As an autonomous professional, you are responsible for making informed, well-reasoned decisions about your practice to maintain alignment with these standards. This includes actively seeking guidance from educational institutions, employers, colleagues, and other relevant sources to ensure that the wellbeing of those you serve remains the highest priority.

Professional Competency Portfolio

As part of the IRP application process, you must submit a Professional Competency Portfolio. This portfolio serves to illustrate how you meet the established criteria and apply your knowledge and training in practice. The portfolio must contain two key components:

- 1. **Background** This section provides context to your resume/CV and links your experience to the specified competencies herein.
- 2. **Case Study** A detailed example that clearly demonstrates your competencies in action, relevant to the accreditation you are pursuing.

The full portfolio should not exceed **3,000 words**.

Areas of Competency for IADMS Recognized Professional (IRP) Candidates

The following ten areas of competence represent the core criteria that all IADMS IRP candidates are expected to meet. To be eligible, you must provide clear evidence of your capabilities in each of these areas, as they reflect the foundational elements of safe, effective, and ethical professional practice within your field of expertise.

Use the competency charts provided in this guide to inform and support both your portfolio background and case study. Be sure to reference at least one objective achieved within each competency area. In both the background and the case study, explicitly identify which specific competency area each piece of evidence addresses; ie. 'I learned My clinical dissertation project included creating a 2-day continuing education course titled "Performance Enhancement & Resiliency in the Dancer" in conjunction with statistical analyses to assess participant learning (4.2,4.6,4.4).'

Ten Competencies

1. Knowledge

Demonstrate a comprehensive and detailed understanding of key concepts, principles, and practices relevant to your area of expertise.

2. Technical Skills

Show full understanding and effective application of techniques and tools appropriate to your professional domain.

- 3. **Application of Knowledge and Skills** Provide evidence of how you apply your knowledge and technical skills within real-world or practice-based environments relevant to your field.
- 4. **Understanding and Use of Research** Demonstrate how current research and best practice evidence inform and shape your professional decisions and approach.
- 5. **Self-Evaluation and Professional Development** Show your ability to critically reflect on your practice, take responsibility for your actions, and engage in ongoing professional development.

6. Communication

Demonstrate effective communication skills—both written and oral—across a range of audiences, including colleagues, clients, and peers.

- Problem Solving and Impact
 Provide examples of how you identify and address challenges using evidence-based reasoning to achieve positive, timely outcomes.
- 8. **Management of Self, Others, and Practice** Show an understanding of professional management responsibilities and demonstrate your ability to manage yourself, others, and your practice effectively.

9. Understanding of the Delivery Environment

Demonstrate awareness of, and integration into, the specific working environment relevant to your domain.

10. Professional Relationships and Behaviors

Uphold and model the highest standards of ethical conduct, professionalism, and collaborative working with clients and colleagues.
